



## “Shoes For Life”

### CHARITY RAFFLE RULES AND REGULATIONS

**Gustave Roussy is Europe’s leading cancer centre for care and innovative research. As a non-profit making body with a public role, Gustave Roussy organises charity operations to raise funds and further its fight against cancer.**

#### **ARTICLE 1 – ORGANISATION**

Gustave Roussy is organising a charity raffle called “Des Souliers Pour La Vie”/ “Shoes For Life” in aid of its cancer research. Gustave Roussy has called on the generosity of its main sponsoring partner, the CSNB (Chambre Syndicale Nationale des Bottiers - National Association of Shoemakers), to obtain prizes.

The raffle has been authorised by Villejuif City Hall in accordance with current legislation.

#### **ARTICLE 2 – PARTICIPANTS AND CONDITIONS FOR PARTICIPATION**

**2.1** The raffle is open to all individuals of adult age residing in France and worldwide.

**2.2** Depending on geographical region, the following means of payment will be accepted:

- Carte Bleue, Visa, Mastercard, Amazon Pay, PayPal, Google Pay, American Express.

**2.3** Any individual having bought a ticket in advance on the dedicated page of the website [soutenir.gustaveroussy.fr/dessoulierspurlavie](https://soutenir.gustaveroussy.fr/dessoulierspurlavie) may participate in the raffle.

By purchasing a ticket to participate in the raffle, participants are considered to have fully accepted these rules and regulations without limitation or qualification.

**2.4** 10,000 tickets will be made available for sale at the price of twenty (20) euros each<sup>1</sup> with no limit on the number of tickets per participant.

Following their participation, the participant will receive a confirmation email indicating a unique number that will be used for the draw. If a participant buys several raffle tickets, they will receive one number per ticket purchased.

<sup>1</sup> The purchase of a raffle ticket will not be tax-deductible.

2.5 The participant wins if the number of the ticket they bought is drawn.

2.6 A participant will be immediately eliminated from the raffle without notice if any cheating is proven.

### ARTICLE 3 – PRIZES

3.1 The raffle offers the following prizes:

- **The main prize** is a pair of men or women's **made-to-measure shoes** (prize value: €7,000);
- **Several other secondary prizes**, donated by member companies of the sponsoring partner – the CSNB –, will be offered:
  - A pair of sneakers (excluding exotic leather) from the Atelier du Tranchet (choice between the “Dragon Fury” or “Sneakers Mc Fly” models) (prize value: €850);
  - An “Un Jour” bag from Maison Berluti (prize value: €3,000);
  - A pair of MTO sneakers (“Made To Order”, excluding exotic leather) from Maison Clairvoy (prize value: €890)
  - A pair of ready-to-wear shoes: the “Arca” model from Maison Corthay (prize value: €1,450);
  - A pair of ready-to-wear shoes: the “William” model from John Lobb (prize value: €1,205);
  - A pair of ready-to-wear shoes: the “Andy” or “Alessandro” model from Maison Berluti (prize value: €1,750);
  - A pair of ready-to-wear pumps: the “Kate” model in calfskin from Maison Louboutin (prize value: €575) or a pair of ready-to-wear men's shoes: the “Greggo” model in black calfskin (prize value: €650)
  - An evening dinner show for two people at the Moulin Rouge (prize value: €430)

3.2 For the main prize, the manufacture of the made-to-measure shoes will be undertaken by several shoemakers, chosen then drawn at random by the members of the CSNB board according to their professional affinities and technical skills linked to the choice of the winner's prize.

This will only be organised and formalised once the winner has chosen their dream shoes.

The winner will have to meet the shoemaker at least three times (measurement, fitting, then delivery).

Ideally, these appointments will take place in Paris.

Depending on the current health situation and the travel restrictions specific to each country, the partner companies will allow their travelling shoemaker to meet the winner in their areas of business.

This is the list of possible destinations:

- USA: New York, Los Angeles, Miami.
- Japan: Tokyo, Osaka, Nagoya, Kyoto.

- China: Beijing, Shanghai, Chengdu.
- Europe: Paris, Milan, Brussels, Munich.
- Hong Kong
- Singapore
- UK

All travel costs, transport, accommodation and catering related to attending the appointment with the shoemaker will be at the expense of the winner. The prize winner will be able to claim their prize only at the location fixed by the shoemakers entrusted with the manufacture of said prize and as per the conditions described above.

To conclude the operation, a prize-giving event will be held in a prestigious venue, to be determined by the CSNB board. The sponsor will present Gustave Roussy with a symbolic cheque. The media and operation's stakeholders will be invited.

**3.3** The order in which the secondary prizes will be drawn will be established at random as per the conditions stipulated in Article 4.1 on the official draw date, before the winning numbers are drawn.

**3.4** In the event that travel is limited or forbidden due to the COVID-19 pandemic, the CSNB will suggest alternative dates to the winner so that they may attend the various appointments with the selected shoemaker.

#### **ARTICLE 4 – DRAW**

**4.1** The prizes will be allocated by a draw on Friday 28 October 2022 by a bailiff (the independent adjudicator) in the presence of a representative of Gustave Roussy and the Chambre Syndicale Nationale des Bottiers. The bailiff will provide an official report of the draw.

**4.2** Only one prize will be allocated to each winning ticket and according to the order of the draw.

**4.3** Once the draw has taken place, all winners will receive an official email by 29 October 2022 at the latest, certifying that they have won a prize, and an official list will be published on the CSNB website. By participating in the raffle, participants are considered to have fully and unconditionally accepted the mention of their full name in the publication of the list of winners on the CSNB website.

#### **ARTICLE 5 – PRIZE COLLECTION**

**5.1 Main prize:** The winner wishing to claim the main prize must contact [csnbottiers@gmail.com](mailto:csnbottiers@gmail.com) before 29 November 2022, providing a copy of their I.D. and of the email certifying that they have won a prize.

The winner will then receive an official document describing the various stages of the manufacture and delivery of the made-to-measure pair of shoes, which will be organised by the partner - the CSNB.

The manufacture of the main prize will take place between November 2022 and December 2023, as per the winner's availability, with delivery scheduled for the second semester of 2023.

**5.2 Secondary prizes:** The winners wishing to claim their secondary prizes will have until 25 October 2023 to contact [csnbottiers@gmail.com](mailto:csnbottiers@gmail.com) providing a copy of their I.D. and of the email certifying that they have won a or several prize(s).

Each winner will then receive an official document enabling them to collect their prize(s). Delivery will take place from December 2022 onwards.

Each secondary prize must be collected by appointment with the partner company - prize provider. If it is possible to send the prize to the winner, the partner company - prize provider will pay all shipping charges.

**5.3** Winners who have not come forward before these dates will forfeit their right to the prize and lose ownership of the asset. If the winners do not contact the CSNB within the required dates, the prize will be awarded to the second person drawn at random by the bailiff (who will have drawn the names of several people to constitute a waiting list).

**5.4** In the event of it being impossible for the winners to meet with the shoemaker, they may offer their prizes to a third-party and will have to inform the CSNB of this, while respecting the aforementioned deadlines.

## **ARTICLE 6 – DURATION**

**6.1** Tickets for the raffle will be on sale from 4 February 2022 during World Cancer Day via the dedicated page on the website [soutenir.gustaveroussy.fr/dessoulierspouurlavie](http://soutenir.gustaveroussy.fr/dessoulierspouurlavie) until midnight on 25 October 2022, which is St Crispin's Day, the Patron Saint of Shoemakers.

**6.2** The physical draw will take place on 28 October 2022.

## **ARTICLE 7 – LIMITATION OF RESPONSIBILITY**

**7.1** Gustave Roussy shall bear no responsibility as a result of organising this charity raffle, particularly if, in the case of force majeure or due to circumstances beyond its control, it is obliged to cancel, curtail, prolong, or postpone the raffle.

Should the raffle be cancelled for any reason whatsoever, those participants having bought tickets will be personally contacted by email to establish whether they wish to be reimbursed or wish for their participation to be converted into a donation for the benefit of the operation's goal.

**7.2** By participating in the raffle, participants are considered to have fully accepted these rules and regulations without qualification.

**7.3** Gustave Roussy shall bear no responsibility in the event of a technical incident preventing connection to the dedicated website for participating in the raffle and/or the collection of donations.

**7.4** Gustave Roussy accepts no responsibility with regard to the organisation of the manufacturing stages of the prizes, the terms of delivery and the condition of the prizes on delivery.

## **ARTICLE 8 – FILING AND CONSULTATION OF RULES AND REGULATIONS**

Within the framework of these rules and regulations, Gustave Roussy, which is responsible for data processing, undertakes to take every possible precaution to uphold the rights of the individuals concerned and to safeguard the security of the personal data in accordance with the existing regulations applicable to the processing of personal data and, in particular, Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 applicable as of 25 May 2018 as well as French law n° 78-17 of 6 January 1978 relating to information technology, files and civil liberties (modified) and all its implementing legislation.

#### **ARTICLE 10 – APPLICABLE LAW - DISPUTE AND LITIGATION**

**10.1** These rules and regulations are governed exclusively by French law.

**10.2** The prizes offered may not give rise to any dispute of any kind, nor to their exchange value in money, nor to their exchange at the request of the winners.
